**OLD BUSINESS**

1. Grad students get a 'scholarship'; half off their SECOL dues in honor of Bob Bernstein. STATUS: this has changed **to the Bernstein award**. As listed in the newsletter and on the call for papers and and reprinted here:

**The Bernstein Award**

The Bernstein Award of \$100.00 for the best paper on Language and Politics is open to all SECOL members. To be considered, an electronic copy of the full paper transmitted by e-mail as a PDF file (or three hard copies by regular mail) should be sent to Dr. Megan E. Melancon with a cover letter requesting consideration. Your letter should contain contact information. The deadline for submission of the full paper is **January 12, 2009**.

As was decided in last year's Executive Committee meeting, SECOL will annually, for the next **five years**, fund this award for a paper in Language in Politics with a prize of \$100.00. Cindy Bernstein's donation will constitute the first award. The prize will be open to all members. The EC will assess the level of interest in the award in 2013.

COMMENT: no one applied for it this year, although it was listed in the Call for papers and in the Winter 2008 newsletter.

2. For the ROA, we had two submissions. The winner was Janneke Van Hofwegen. She will receive ROA - \$100 dollars and a three year membership to the organization.
3. The other award was the Steve Gross award, also announced in the Winter 2008 newsletter and in the call for papers. We had one submission. I consulted with Theresa McGarry and Robin Sabino and we decided to accept it. The winner is Jill Hallett. As a reminder:
