A. Reza Ordoubadian Award

The deadline is January 7, 2017, to send papers to Catherine Evans Davies, the secretary.

B. Officers

1. Mary Zeigler rotates off the Executive Committee and Becky Childs rotates off the Nominating Committee this year. Incoming nominees Paulina Bounds (Nominating Committee), Ramón Escamilla (Executive Committee) and Paul Reed (Treasurer) will be considered until June 1. If there are no objections, they will assume their duties on June 2.

2. The Webmaster position will in due course be shared between the Treasurer and the Secretary working together. Wilbur Bennett has agreed to stay one more year to supervise the transition until Paul Reed and Catherine Evans Davies take over the webmaster duties.

3. As of the time of the meeting the position of Vice President following Ralf Thiede was open, but since then Phillip M. Carter of Florida International University has agreed to serve as Vice President beginning in 2017.

C. Journal

Felice Coles is looking for manuscripts, book reviews and evaluators. All members are welcome to submit previously unpublished work and to volunteer to read manuscripts. The journal also has open two issues for memorial volumes for Megan Melançon and Becky Moreton. Guest editors are welcome. (Later, Tamara Lindner and Shana Walton expressed interest in those volumes, and Felice promised another issue dedicated to linguistic ownership/copyright.)

Members will be notified by June 1, with appropriate explanation, that voting can be done by logging onto the SECOL website and voting there or by sending a ballot (downloadable from the website) to the Secretary (cdavies@ua.edu). The voting will be open until October 1, 2016. If any or all items are accepted by the membership, a revised Constitution will be drafted. Please note that if you are not currently a member and would like to participate in the voting, you can pay your membership dues via the website.

F. Other Business

1. Catherine Evans Davies assumes the position of Secretary now. Sasha Johnson Coleman was thanked for her service.

2. The University of Kentucky will host the LSA Summer Institute in 2017. If members attend as affiliates, then their registration fees pay for student scholarships. Jennifer Cramer and Catherine Evans Davies encouraged everyone to attend.

3. Everyone was welcomed to the closing reception on Wednesday, March 31, with an open bar in the St. Ann Room of the hotel.
